#### MAA Newsletters, Jodi Boyle and Michael Martin --

Editors published the Spring 2019 issue of the *Mid-Atlantic Archivist* in March and it was distributed as of April 5. Editors continue to try to secure former MARAC chairs who served at least 10 years ago to contribute to the "Reflections" column in the publication, writing about their time in MARAC and the organization as it approaches its 50<sup>th</sup> anniversary.

MAA editors worked with the MARAC Web Team to review and suggest edits to the redesigned Publications portion of the MARAC web site.
