### Awards Committee Report July 20, 2020

I met with the incoming MARAC Chair and Administrator to discuss some issues and procedures relating to the function of the Awards Committee.

The three of us also met with the chairs of the various awards committees to discuss procedures, updates to the committee manuals and MARAC Operating Manual and other issues of interest. Both meetings were very productive.

### **Individual Committee Reports**

#### Custer Award From Jasmine Smith, Committee Senior Co-Chair

As the spring conference was cancelled, the Senior Co-Chair is not aware of relevant Custer business to report from the spring.

This quarter, the Senior Co-Chair worked with the steering committee to decide how to accept mailed submissions and protect personal information while the Senior Co-Chair teleworks, as do most committee members.

To date, the committee has received five submissions for the Custer award. Reminder notices will be sent or posted as practical, though we expect that furloughs, layoffs, telework and increased family obligations may limit reach to eligible parties. The committee increasingly promotes digital submission each year, this year listing email instructions first in the Call for Submissions. We want to encourage digital submission while trips to post offices may be inadvisable. Physical submissions are still accepted, and one of the early submissions was sent by mail so far.

#### **Distinguished Service**

No report as they completed their work at the Spring Meeting.

#### Finding Aids/Finch Award

From Phoebe Kowalewski, Senior Chair Finding Aids Award

I took over the position of Senior Chair from Julia Novakovic in June 2020, and the committee's webpage was duly updated. Upon the transition, I sent an email to committee members in order to welcome newcomers, share the handbook, as well as go over duties and timelines.

After Sara Predmore sent out the official call for submissions for the C. Herbert Finch Online Publication Awards, I requested members share the announcement with archives-related listservs, forums, and social media groups. These have included the Archivist Roundtable of New York, the SAA Announcements listserv, and a couple of archivist Facebook groups. As of July 17<sup>th</sup>, three submissions have been received. Although there are currently only two weeks until the deadline, I am continuing to publicize, and have contacted the Delaware Valley Archivists Group, MARAC Caucus leaders, and plan to reach out to others. After the deadline has been reached, I will contact committee members in order to share the submissions and schedule a Zoom meeting for early-mid August so we can make a decision.

#### Scholarships - Note: This report includes an action item for Steering.

From Cindy Bendroth, Scholarship Committee Chair

Due to the cancellation of the spring meeting, no awards were given. The Chair has updated the Committee Manual and submitted it to the Secretary.

#### **MARAC Scholarship Question**

MARAC has had to cancel the two meetings it normally holds in 2020. With the several thousand dollars not spent to assist archivists to attend our spring and fall meetings, most of the Scholarship Awards Committee has expressed an interest in donating the funds to SAA's Archival Workers Emergency Fund (AWEF).

The Society of American Archivists Foundation created the AWEF to support archival workers experiencing financial hardship during the COVID-19 crisis. Grants of up to \$1,000 will be awarded to financially vulnerable and at-risk workers. All U.S.-based archival workers affected by the COVID-19 crisis are eligible to apply to the fund.

Since COVID had impacted MARAC members, we would like to donate funding that would have gone to support awards for archivists attending our conferences to those who may no longer have a job. MAC and NEA has or is considering donating their scholarship funds to AWEF. The Scholarship Committee would ask that MARAC do the same.

#### **Background on MAC Donation:**

MAC donated over \$1200 collected in 2019 for the Student Annual Meeting Registration Scholarship to the AWEF. To that amount, MAC supplemented about \$300, for a total of \$1500. MAC membership then voted to make an additional donation of most of MAC's "profits" from 2019, another \$1500, to AWEF at our annual business meeting.

MAC did not donate funds collected for the Mark A. Greene Emeritus Scholarship (to support first-time annual meeting attendance for a new professional) to the AWEF, largely because MAC is working to endow that scholarship.

MAC's Student Annual Meeting Registration Scholarship is not endowed or governed by committee. Rather, it is managed by the treasurer and simply amounts to donated funds designated for offsetting the annual meeting registration fee for students. The number of awards made in any given year depends on the amount of money donated the previous year and the meeting registration fee. MAC gives the money away by random drawing of eligible student attendees. As a result of all of this, there wasn't much red tape to cut through.

Membership was not informed of Council's decision to donate the student scholarship money in advance. When we told the membership at the annual business meeting, MAC leadership received very positive feedback.

#### **Background on NEA Donation:**

On Monday, June 1, 2020, the New England Archivists donated \$2,000 to the AWEF. This donation money comes from unused scholarships originally allocated to fund travel to the NEA Spring 2020 Meeting. Although this money could not fulfill its original purpose, it can still provide critically

important support to those in need. These are financially uncertain times for many people and professional organizations, and we believe it is our duty to stand with our colleagues by giving what we can.

#### Mid-Atlantic Archivist (MAA)

The summer 2020 issue of the MAA was published online on July 1. This issue included three submissions from presenters/authors originally intended to present at MARAC Harrisonburg. The print version was distributed via postal mail soon afterward. After a delay because of the COVID-19 shutdown of the Print Center at Dickinson, the print version of the spring issue of the MAA was printed and distributed by the first week of June (online version published March 25).

The MAA will transition to a predominantly online publication in winter 2021.

#### Social Media

Since April 2020, original content has been published 7 times on Twitter, with posts being seen 15,274 times. During this period, the MARAC Twitter account has had 140 profile visits, 16 mentions, and 17 new followers. The current follower total is 863.

The MARAC Facebook page has gained 32 new members for a new total of 693. There have been 33 new posts by both the Social Media Manager and by various members, especially as relates to the COVID-19 pandemic and the Black Lives Matter movement.

On both Facebook and Twitter, the most popular post was the announcement of our donation to the AWEF. Six new blog posts were published since April 2020 and subsequently shared through Facebook and Twitter channels.

#### **Technical Leaflets**

The Technical Leaflets editoral board has received two submissions and remains on track for publication before the end of 2020. Furthermore, the editorial board is codifying their processes for inclusion in the operations manual.

The communications committee met on July 13<sup>th</sup> and discussed several new initiatives including:

- Efforts have begun to explore whether MARAC will be offered a digital equivalent to the free table at the SAA conference that MARAC has utilized in past years to promote the organization. This effort is ongoing and will include an update to the operations manual describing the process for arranging a table at SAA in co-ordination with a previous committee chair.
- The committee effort to support state caucus-level "Virtual Town Hall" discussions has been successful following a message delivered to members via email. Committee activity included connecting the Delaware Caucus with the MARAZ Zoom account and we look forward to continuing to support end encourage local, virtual engagement.
- A review of the operations manual has prompted the removal of Communications Committee responsibility for regular, day-to-day updates to the MARAC website. Additional templates and committee assignment information are also being added to the manual.
- Dana Dorman volunteered to work with Social Media Manager Kathleen Donahoe to produce content to be shared on social media and the MAA about National Archives Month and National History Day. This committee activity is in an effort to meet a strategic planning assignment.
- Co-chair Michael Martin is working with Ilhan Citak and Paige Newman of the Education Committee. The idea was to have MARAC host/sponsor a series of webinars to this would give additional opportunities for members since both conferences this year were cancelled. They are called occasional because we don't know the level interest and would like this to continue without a set schedule. There two that are already set on July 29<sup>th</sup> and August 5<sup>th</sup>. The committee would like to open it up to others and we are considering a larger call for proposal. There also was a discussion about recording these webinars. It was decided that recording would makes sense and the recordings could be stored in DRUM. It was agreed that a write up is needed for promotion as July 29<sup>th</sup> is very near. This will include description and deadline for date to register. This needs to be done by the 20<sup>th</sup>.
- To explore and report on the feasibility of offering vendor ads on the MARAC website, a subcommittee comprised of Missy Nerino, MAA Assistant Editor; Jodi Boyle, MAA Editor, Lara Szypszak, Advertising Editor; Sara Predmore, Ex-officio; Michael Martin, Co-chair; and Molly Tighe, Co-chair has been formed in response to advertiser interest. It was noted that while MARAC has the capability to host sponsor ads on its website testing should be done before it is offered to vendors. The following questions will need to be addressed: Who oversees the money? Do the rates change for web ads rather than the MAA or a conference? Will there be a bundle in MAA and web ads together? There are advertisers are only approachable for conference. Do they see this as a good alternative? Who makes the final decision on this? It is expected that the subcommittee will discuss the matter with MARAC Treasurer, Vender Rep, and more. The subcommittee will meet following the MARAC Steering Committee

#### New Member appointed

Ali Zawoyski was officially appointed to serve a two-year term on the committee. Rayna Andrews, and Marci Bayer also were agreed to serve for another year on the committee.

#### **MARAC Statement on Black Lives Matter and Resources**

In collaboration with member of the executive committee, The D&I committee drafted and released a statement on Black Lives Matter and Resources in response to the killing of George Floyd and the resulting national wave of protests. See the statement appended below.

#### Forum on Safe and Ethical Collecting During a Crisis

On June 16, the committee hosted an informal online discussion on Zoom about safe and ethical collecting during times of crisis. The forum, moderated by members of MARAC's Diversity and Inclusion Committee, had over 100 participants. Participants shared advice about such topics as when, or if, to directly collect protest-related materials and when to partner with/support another institution that might be better suited to manage the acquisition process, community relations, partnership building, and ethics statements.

While the Black Lives Matter, anti-racism protests and COVID-19 pandemic offer an opportunity for archivists to "document the moment" for the future, participants also stressed the need to proceed with sensitivity, concern, and thoughtfulness.

#### Committee to host more online forums

Seeing the success and the member participation of last forum, the committee supports making these forums a semi-regular event. There are a variety of suitable topics including the current discussion around monuments and the issue of precarious employment just to name two.

#### **Program Committee coordination**

Josué Hurtado will serve as the liaison with the Saratoga Springs program committee, and new committee member Ali Zawoyski will serve as liaison for the Gettsyburg program committee.

#### Appendix: MARAC Statement on Black Lives Matter and Resources

The following statement was released on June 3, 2020.

The Mid-Atlantic Regional Archives Conference (MARAC) stands in solidarity with protesters against violence and racism towards Black Americans and people of color. We condemn the systemic and institutionalized racism, militarization of law enforcement, and unchecked violence committed by the state that led to the murder of George Floyd and so many other Black people. We affirm that Black Lives Matter and support the right to protest peacefully against injustice without violent response.

We recognize that archives have historically been located in institutions and frameworks that reinforce white supremacy and that our organization needs to do more to support efforts to dismantle the historical legacy of oppression both within our organization and within our individual institutions.

We ask our MARAC members to commit to addressing anti-blackness and to leverage whatever skills, power, and privilege they have towards dismantling oppressive systems in our institutions and communities. We stand with communities everywhere demanding justice.

#### **Ethical Collecting of Protest-Related Materials**

To archivists and institutions who are considering collecting protest-related materials, there are important ethical considerations to be aware of, the most important of which is prioritizing the privacy and safety of protesters. It is also appropriate to NOT build protest-related collections if such collection building cannot be done mindfully, safely, and ethically so that they cannot be used to inflict harm. Institutions should also be aware that secondary trauma can be experienced by staff members processing these types of collections.

For further guidance on ethically collecting protest materials, please consult the Guidelines from <u>Documenting the Now</u> and <u>Guidelines</u> from <u>Witness</u>, as well as resources found on the <u>Archives</u> for <u>Black Lives</u> site.

MARAC will also host an online discussion on safe and ethical collecting on June 16, 2020 at 1PM Eastern Time. This informal event, facilitated by members of the Diversity and Inclusion Committee, will be a forum for members to share ideas and concerns and discuss ways in which we can support the efforts of those already doing this work. Connection details for this discussion follow this message.

# MARAC Education Committee Report – July 17, 2020

#### Activities:

Education Committee working on offering virtual presentations and workshops.

Virtually met with Ilhan Citak and Michael Martin and discussed hosting MARAC Occasional Webinars. Occasional Webinars topics will vary but will be relevant to MARAC and current events, open to 100 participants via Zoom, and will last no more than one hour. Presenters will work with the Workshop Coordinator to coordinate these programs.

Waiting to confirm the dates for two Occasional Webinars:

#### "Publishing the Brown and White During the Pandemic" Matt Veto - Lehigh University - Faculty - Journalism

For 126 consecutive years, Lehigh University's "The Brown and White" student newspaper had been delivering campus and community news to its readers, and it continued to do so despite the university's closure due to the COVID-19 global pandemic. In anticipation of Lehigh's likely closure — and just hours before the official announcement — the student editors and faculty adviser developed and launched a remote production protocol that ensured the continuity of the print product despite the challenges of displacement. Sending their first remotely produced paper to the printer mere minutes before a 6 a.m. deadline, the team officially commenced its journey of news production in a new era. The cover of that issue blared "GLOBAL PANDEMIC: COVID-19 fears force students home; Lehigh goes remote" and was followed by 11 more hard copy editions to go along with 24/7 coverage online. The team of more than 160 student editors, reporters, photographers and videographers became a group of global correspondents, continuing to cover events close to home, while also providing perspective from afar.

#### Bethlehem Steel, Industry, and the 1918 Influenza Pandemic

102 years ago, the great influenza pandemic swept across the globe, claiming as many as 50 million lives. In the United States, Pennsylvania was hit the hardest. More than 67,000 Pennsylvanians died during the crisis' most acute phase. This haunting and timely look will examine the virus's impact on industry, and detail how the then-prosperous Bethlehem Steel helped the community around it suffer some of the lowest mortality rates.

### **Progress and News**

- <u>New Member Meet & Greet</u>
