Steering Committee Meeting  
January 23, 2026**

1. The New Jersey Caucus welcomed 4 new members this quarter.
2. On Saturday, November 1, 2025, the inaugural New Jersey Archival Film Festival was held at Monmouth University. The event was presented in partnership with the New Jersey Studies Academic Alliance (NJSAA), the Bruce Springsteen Archives and Center for American Music, and the New Jersey Caucus. Representatives from 18 GLAM organizations across the state (including local museums and historical societies, large state institutions, and private institutions) screened films from their collections. The festival was well attended, with approximately 60 audience members from both the archival community and the general public. Planning is underway to host a similar event next year.
3. A feature article about the New Jersey Archival Film Festival was submitted to *Mid-Atlantic Archivist* for the Winter 2026 issue.
4. Contacted the Web team to update the NJ Caucus page with links to the [CAPES Archival Resource List](#). Contributions to the resource list were provided in part by New Jersey Caucus members, and the list serves as an ongoing reference for archival suppliers, vendors, and educational resources.
5. The New Jersey Caucus Archival Supply Exchange was launched, creating a space for caucus members to connect, share available supplies, and offer items for donation.
6. Attended the December 2025 quarterly meeting of caucus representatives.
7. Held NJ Caucus meeting on December 8, 2025 at 1pm.
