Diversity and Inclusion Coordinator's Report Mid-Atlantic Regional Archives Conference Geof Huth and Molly Tighe 9 April 2018

The MARAC Steering Committee reviewed the report of the Task Force on Diversity and Inclusion at its April 2017 meeting. At that time, Steering recommended the Diversity and Inclusion Committee would be a special committee appointed by the chair and that the head of the committee, the Diversity and Inclusion Coordinator, sit on Steering. Effecting this change would require a vote of the members to change the bylaws, which vote has not yet occurred.

At its July 2017 meeting, Steering Committee decided to hold a Diversity and Inclusion town hall with the membership at the fall 2017 meeting in Buffalo, New York. Geof Huth and Molly Tighe, both at-large members, volunteered to arrange and run that town hall and to serve as the interim diversity coordinators until a formal committee was established.

At the MARAC meeting that fall, Molly and Geof led a discussion with a few hundred members about diversity and inclusion in MARAC and how the organization should address and improve that situation. Opened by Vin Novara, this town hall discussion began with a synopsis of the report from the Task Force of Diversity and Inclusion. Most of the meeting, however, was a discussion of diversity and inclusion in the profession and how to address that issue. To ensure access to this session, Ilhan Citak streamed the entire session on Facebook Live. The interim coordinators created a summary of this discussion, based in large part on the notes on the meeting taken by MARAC secretary Jennie Anne Levine Klein, and this was published in the next issue of *Mid-Atlantic Archivist*.

In mid-January of 2018, the MARAC Steering Committee held a discussion on whether it should release a statement in response to President Trump's racist comments on "shithole countries" versus countries such as Norway. Although members of Steering Committee were outraged by these comments, members decided this was not an archives issue and that MARAC could not reasonably respond to all social and political controversies that arose in the nation.

In early April, Vin Novara reached out to the interim coordinators to discuss MARAC providing conference attendees at the meeting in Hershey, Pennsylvania, with a means by which to communicate their preferred pronouns. The three of us agreed that this was a good idea and decided that ribbons to attach to nametags would be the best solution for us. Novara ordered and paid for the ribbons himself. Molly Tighe drafted a blog posting on the ribbons, which Huth signed on to, for the conference blog, and the ribbons will be available at our April 2018 meeting.

Newsletter *MAA*: Jodi and Michael will be implementing a new series in the upcoming newsletters which will debut in the Summer issue. "MARAC Turns 50" will be a regular feature where past chairs will reflect on the significance of MARAC over the past 50 years, note how their time as chair affected their overall archival career, and share some memorable MARAC moments. The first past chair to be participating in the column will be Ron Becker. Jodi and Michael hope to have other chairs provide similar contributions (either as written submissions or in the form of a phone interview) in upcoming issues leading up to the 50th anniversary in 2022.

The latest issue of the MAA was published in late March 2018.

Blog/Social Media: Lynsey has been maintaining the blog and social media, advising the Hershey publicity team on social media, and contacting the Hershey program editor to make sure that hashtags are included in the Hershey program. After this conference, Lynsey will be cycling off of the committee. Potentially taking her place will be Laura Cleary. She was recommended as a replacement and we are currently reaching out to her to see if she is interested in the position.

Technical Leaflets: Chris and Heidi have been investigating registering the Technical Leaflets to become a peer-reviewed publication. In the final editing stage is the *Digital Exhibitions*: *Concepts and Practices* leaflet which will be ready for full publication shortly. To date, with the help of Sara Predmore, they have applied for an ISSN number which is one of the beginning steps in the process. Chris also mentioned that we should probably have an author contract form that formally permits MARAC to publish the leaflets or other peer-reviewed publications. Chris has an example of a contract he drew up for MARAC which will be sent out for approval before we begin using it. (See Appendix A)

Lastly, the Communications Committee teamed up with members Molly Tighe and Geof Huth who were moderating the Town Hall meeting which focused on Diversity and Inclusion at the

MARAC Meeting in Buffalo, NY. They suggested we livestream the meeting via our Facebook page which we did. (<u>https://www.facebook.com/groups/7834911567/</u>)

Ilhan set up his phone on a tripod to film the event and I, with the help of other Steering members, monitored the feed in order to catch questions and comments. While the livestream did not have a huge amount of people watching or asking questions, we were still happy with the type of access we were able to provide to members.

Progress and News

• <u>Mentorship Program</u>

We hoped to have a mentorship program ready to roll out, but in exploring similar programs, came up with several questions that we would like input from Steering to answer.

- Other local professional archivists associations expressed concerns that, while they wanted to set up a mentoring program, they didn't want to impinge on SAA's efforts. Do we share this concern?
- One program, the Midwest Archives Conference, runs a similar program, but is having trouble balancing their demographics. In their case, they have many more mentors that mentees, which is a problem we've had with the Conference Liaison Program.
- We looked at similar professional organizations (SAA, AAM, AASLH, MAAM, ALA, MAC) and many focus their networking opportunities on their in-person events, such as their annual meetings. Do we take a similar approach or capitalize on the vacuum and enact a mentoring program, understanding that it might be more virtual than in-person? One barrier we would like to overcome is that many in-person networking events require travel (for instance, to the conferences) and other economic hurdles that might prevent participation for students or new professionals.
- How would mentors and mentees be matched?
- We thought perhaps a survey to gauge the appeal of the program is in order. We want to investigate targeting a particular audience with the survey, rather than the entire group, to really focus on what will be most helpful. We will work to draft a survey and work with the Administrator so that the right people answer our questions.
- <u>Conference Liaison Program</u> Once we have established more framework for the Mentorship Program, we will work on getting this program back to functional status.
- <u>Changes to Caucus Listservs</u> Sara Predmore brought forth a proposal that would change the way that caucus

listservs are handled through MemberClicks. Currently, administering the caucus listservs requires a lot of intervention on the part of the Administrator. In addition, the recent MemberClicks upgrade allows members to have broader access to join listservs through their online profiles without administrator intervention. Please note that the below proposal is not suggesting that the fees for joining listservs be changed, simply that MARAC allows members to control their own subscriptions without the Administrator, thus freeing more time for the Administrator to handle more important tasks.

- Proposal: The Administrator proposes that members have access to join and manage their caucus listserv preferences without Administrator intervention and that all caucus listservs are open to all members regardless of designated caucus.
- Justifications:
 - Information shared through caucus listservs is normally about events, legislation, and job opportunities. This is good information for everyone. In our efforts to be inclusive, this information should be open to all members by allowing them to join whatever caucus listservs that they want and give them the system access to do it themselves.
 - We should maximize the capability of the system upgrade instead of trying to work around it. Currently, in trying to keep the same process that we used with the old system where the Administrator subscribes people to the caucus listservs, the new system requires an additional transaction per person using group assignments and consequently limits member access within their profiles.
 - This change would empower people to control their listserv preferences and hopefully help them to become more comfortable in using our website and managing their profiles.
 - A how-to guide would be created and sent (more than once) to assist members in managing their preferences.
- <u>Upcoming Priorities: Graduate Students</u>
 - Survey for graduate students: What do they get out of MARAC? What would they like to get out of MARAC? Would they like to be more involved and, if so, how?
 - Should or could MARAC have a graduate student representative on its Steering Committee? How would this position be established, through election or appointment? What would the responsibilities of the position be?
