The Development Committee approached several vendors, and Gaylord was the one vendor to respond. An email will be going out with more details about the Disaster Assistance Fund and how to contribute.

Next year is the 40th anniversary of MARAC. To recognize this achievement, scholarship offerings will be increased to forty over the year.
