The Custer Awards Committee is pleased to announce the 2013 award recipients.

The Arline Custer Memorial Award for Books goes to E. Richard McKinstry for his book, *Charles Magnus, Lithographer: Illustrating America's Past, 1850-1900*.

Published by Oak Knoll Press in April of 2013, *Charles Magnus, Lithographer: Illustrating America's Past, 1850-1900* is a visual delight that provides a well-written, clearly organized resource for exploring Magnus' important work as a leading lithographer in the United States in the late 19th century. McKinstry analyzes Magnus' within the context of the immigrant experience, highlighting the lithographer's significant artistic contributions now imprinted upon the American record.

The Custer Award for Articles goes to Christine Anne George for her article, *Archives Beyond the Pale: Negotiating Legal and Ethical Entanglements after the Belfast Project* published in the *American Archivist* in May of 2013

The committee felt the article provided a thought-provoking treatment of the Belfast Project oral histories case with a thorough survey of the legal basis for the concept of privilege as applied to journalists, scholars, and archival collections. Moreover, George challenges the professional archival community to consider how to protect the rights of participants in oral history interviews.

The Committee received 10 nominations for the Custer Award. The committee will continue to research publicity venues for the award announcements.

Copyright Fundamentals for Archivists and Librarians – Wednesday, October 23, 2013

Location: University of Pittsburgh

Instructor: Peter Hirtle, Cornell University Library. Number of attendees: 40

Description: Even in the best of times, the uncertain copyright status of archival and special collection materials makes many archivists and librarians uncomfortable. As more and more repositories think about making material available on the web, anxiety about possible copyright infringement increases. This workshop will explore what strategies special collections can follow to minimize the risks inherent when reproducing and distributing unique and/or unpublished material. Topics covered will include an introduction to basic copyright law and the Digital Millennium Copyright Act; exemptions to copyright such as fair use and the specific exemptions for libraries and archives; methods for assessing the copyright status of materials; and issues associated with particular formats. Attendees should leave with a better understanding of the basics of copyright and be in a better position to work with senior administrators to establish a mutually acceptable level of institutional risk.

Project Management for Archival Processing, Friday, September 27, 2013

Location: National Archives & Records Administration, College Park, MD **Instructor:** Vincent Novara, University of Maryland. **Number of attendees: 30**

Description: This workshop focuses on introductory techniques and common tools for project management. Workshop participants will learn how to establish, define, plan, implement, and execute archival projects. Attention is given to strengthening prioritization skills and workflow planning as they pertain to processing projects executed by various levels of staffing, including the lone arranger. The workshop also addresses interpretive projects such as exhibitions and digital initiatives. Attendees will learn how to determine project goals and objectives, compose project objective statements, establish work breakdown structures, estimate project budgets, create project and communication plans, schedule and track tasks using Gantt Charts, and conduct a post-project evaluation. Throughout the workshop, standard project management terminology is applied to common archives tasks, and an overview is given of Earned Value Assessment.

Fall 2013 NATIONAL COALITION FOR HISTORY REPORT MARAC Steering Committee Meeting Philadelphia, PA--Nov. 7, 2013

Last summer, the National Coalition for History (NCH) Policy Board adopted a new membership and marketing plan for the organization. Although this doesn't affect MARAC per se, a threshold of \$500 has been set for membership as of 2015.

In September, NCH Executive Director Lee White succeeded in establishing a Congressional History Caucus in the House. The lead co-chairs are Representatives John Larson (D-CT) and Tom Cole (R-OK). The other two co-chairs are Representatives Ander Crenshaw (R-FL) and Bill Pascrell (D-NJ). Congressman Larson's office is developing a "Dear Colleague" letter to be circulated among fellow Members of Congress urging them to join the caucus. The History Coalition's role is strictly advisory and does not see this as an opportunity to advocate for anything. Now that the History Caucus is established in the House, NCH will be take steps to form a similar one in the Senate.
