## Candidate Bios

(Candidates for each position are listed in the order in which the nomination was received)

### Chair-Elect (1 position)

#### **Jessica Wagner Webster**

Jessica Wagner Webster serves as the Digital Initiatives Librarian in the Archives and Special Collections department at Baruch College, City University of New York. She holds an MLS with an Archives concentration and an MA in American History, both from the University of Maryland.

She has worked in archives in some capacity since her undergraduate days, when she fell in love with the field after having been hired as a student worker in her university's archives and special collections department. Since that time, she had held professional positions or completed internships in academic institutions, historical societies, museums, and the government sector, giving her a wide range of experience in the archives world.

In her current and recent roles, she has performed reference, processed and described print and digital collections, implemented ArchivesSpace, and established workflows and for print and digital access and preservation. Additionally, in her current role as Baruch's first Digital Initiatives Librarian, Webster develops programs to acquire, process, describe, provide access to, and preserve digital materials documenting Baruch College as well as its special collections priorities. This has included building a digitization lab, establishing and helming large-scale print digitization projects. She has also widened the collecting policy to include more student materials as part of a goal to broaden the college's documentary record. In addition, she has developed and taught archives-focused undergraduate credit courses. Webster has written and presented widely in the field, on both hands-on archival work and original research. Much of her current scholarly work revolves around outreach and advocacy for investment in archives, support for archival labor, and diversifying the historical record.

Webster is excited to run for chair of MARAC to support relationship-building and professional development. Membership in MARAC and other professional organizations have significantly benefited her career by helping her develop skills, a professional network, and colleagues and mentors to turn to for help in our sometimes isolated field. Along with MARAC, she's been active in the Society of American Archivists and the Digital Library Federation Forum. She's held a variety of positions in MARAC, recently serving on the Nominations and Elections Committee, and serving as co-chair of the Program Committee for the Spring 2018 Conference in Hershey.

#### ***What do you see as your priorities for MARAC?***

Membership in MARAC has been extremely beneficial to my career as a way to network, connect, and particularly develop skills and familiarize myself with new workflows, best practices, and issues in the field. If elected chair, I would like to use the work of the Meeting Model Task Force's survey to identify the best ways to satisfy needs of the membership to connect and professionally develop.

As an archivist and educator, I have come to realize how variable each individual's learning styles and personal circumstances can be. The pandemic has clearly illustrated this. Some prefer to meet, learn, and discuss in person; some do better working remotely, either synchronously or asynchronously; some do not

have the personal or professional resources to attend in-person events. Further, in the last few years MARAC has begun to focus more attention on ways to boost membership and outreach to students, early career professionals, and practitioners in historically underrepresented groups. Providing a variety of offerings will be a boon to all of our membership and could increase our membership enrollment as well.

I understand MARAC will be working on its new strategic plan and the incoming Chair-Elect will be actively involved in that process. I am excited at the opportunity to do that work and study recent research and membership surveys to identify priorities for the organization over the next few years. For me, digesting and responding to member feedback in the development of the strategic plan would be one of the best ways I could impact an organization like MARAC that has been professionally meaningful to me and many others.

***What do you think are the main challenges MARAC is facing and how do you plan to address them?***

I think one major challenge is figuring out how best to serve our members after almost two years of the pandemic, and all the screen-fatigue, burnout, isolation, and of course upheaval, illness, and tragedy that has accompanied this time. How can MARAC be most useful to our members at this time? I want to figure out how to provide members with opportunities for enriching professional connections that are also cost-effective and manageable in terms of time and method of delivery. I think utilizing the results of the Meeting Model Task Force's survey will be key. I think we as an organization should use this opportunity to figure out how best to offer a diversity of workshops, meetings, forums, and networking opportunities while still remaining as fiscally solid as possible.

I also, more generally, believe that archives work is both extremely important and undervalued by society. This not only affects the shape of the documentary record, which is something we care about as archivists, but also shapes the availability of jobs and resources to do this important work. I'd like to explore and prioritize (perhaps in the strategic plan) additional ways MARAC could perform outreach and advocacy for our field, its jobs, and its resources. This could include partnering with other GLAM professional organizations, offering introductory archives workshops to affiliated fields, scholarships to attend conferences in related fields, guest-speaking to undergraduate classes, etc. This could raise MARAC's profile and boost membership while also creating conditions where our work is understood and valued within and outside of the GLAM professions.

## **Treasurer (1 position)**

### **Amy Fitch**

Hello, MARAC! I'm Amy Fitch and I'm honored to run for Treasurer and for the opportunity to represent you as part of the Steering Committee.

A long-time member of MARAC, I'm currently in my second term on the Finance Committee, having previously served from 2016 to 2018. Between then and now, I was Treasurer of the Society of American Archivists from 2018 through the summer of 2021, as well as Chair of the SAA Finance Committee and Treasurer of the SAA Foundation.

I am an archivist at Rockefeller Archive Center, in the suburbs of New York, where I have worked with the Rockefeller family archive for more than a decade. My responsibilities include arrangement and description of personal papers, compliance with donor privacy restrictions, and oversight of classified materials.
